

# FERNDALE SCHOOL DISTRICT

## ONLINE ELIGIBILITY PACKET

*The Ferndale School District's "Athletic/Activity Eligibility Packets and Permission" for students participation, is completed electronically online through Parent's Skyward Family Access and must also be completed through your student's Skyward Student Access in order to be eligible to participate. Fall Athletic Clearance for High School Athletics starts the middle of August and Middle School Athletics start the end of August. You will receive more information in your registration packet from your school in August including Skyward Family Access login and passwords.*

*You will need your Skyward Family & Student Access logins and passwords for Skyward to complete. Please contact the office if you need your logins and passwords.*

Ferndale High School and 7<sup>th</sup> & 8<sup>th</sup> grade Middle School students wanting to be eligible to participate in athletics or activities in a Ferndale School District Sport or Activity will need to complete the following once each school year prior to participating:

- ✓ Parents **AND** students must complete "Athletic/Activity Eligibility Packet" on Skyward Family & Student Access
  - Parents must sign on to their Skyward *Family* Access and complete the Athletic/Activity Eligibility Packet which includes parent permission to participate, code of conduct, risk statement, health insurance information, concussion and cardiac arrest information and summer permission form **AND** students must sign on to their Skyward *Student* Access and complete their portion of the eligibility packet to be eligible.
- ✓ Purchase an Associated Student Body Card (FHS ASB Card - \$40.00 or Middle School ASB Card \$20) which you can purchase once your school offices open in August.
- ✓ Show regular school attendance for the previous semester.
- ✓ Maintain passing grades in all classes per WIAA regulations.
- ✓ Have an up-to-date physical on file\* (Athletes Only - not needed for Middle School Intramural). High School Athletes' physicals are good for 13 months and Middle School Physicals are good for 2 years.
- ✓ Have current health insurance\*\* (Athlete's Only)-(Please contact your school's office if you need to purchase school insurance)
- ✓ Pay all school fines through the ASB office.
- ✓ FHS students will then go to the FHS Athletic Office, Vista & Horizon Middle School students will go to their respective school offices to verify all requirements are met for clearance during each season.


Click on “Families” for the drop down list and then choose Skyward Family Access

Log into your Family Access and if you have forgotten your sign on or password please contact your school’s office

Once you have logged in you will be able to click on “Online Forms” and choose which of your students you would like to complete the forms for at this time. You are able to save your forms and return to complete it at a later time if needed. You will see check marks as you complete each section and be able to submit all of the completed information once each section has a green check mark by it.

**Once the online information is completed by you and your student, all fines/fees are paid and your student has a current physical on file, your student will need to stop by their Middle School or the High School Offices to complete the eligibility process for clearance to participate.**
